Program Description

In 2024, three (3) one-year scholarships (one at \$2,000, one at \$1,500 & one at \$1,000) will be awarded to dependents of members of the Teamsters Union Local 407. Recipient will be selected by an independent agency. Scholarships will be awarded based on the applicant’s scholastic record, results of college admittance tests (i.e. ACT or SAT), community involvement, employment history, and recommendations from individuals familiar with the applicant. Financial need will not be a consideration.

Who is Eligible

Current high school seniors who are dependents of members are eligible to apply. Members must be in good standing and have been an active member for at least one (1) year.

The Teamsters member must be in good standing the day this application is submitted to Teamsters Union Local 407 and the day awards are announced.

Eligible Institutions

Institutions receiving scholarship awards through this program must be recognized as Pell-eligible. Additionally, the institution must be an accredited degree-granting four-year college, university, two-year community college or technical school.

How to Apply

Complete the application form and attach any required documents such as school transcript, letters of recommendation, essay, and SAT or ACT test scores. **Applications must be mailed to and received by April 5, 2024:**

Scholarship Qualifications

To qualify for a Teamsters Union Local 407 Scholarship, graduating high school seniors must



have maintained a minimum of a 2.5 grade point average (based on a 4.0 scale) during his/her high school or years. Additionally, the applicant must fulfill test score requirements of 21 ACT or 1060 SAT or higher.

Selection of Recipients

- The Teamsters Union Local 407 Scholarship will be administered by an independent agency.
- To ensure objectivity, the selection of the scholarship recipient will be made by a selection committee from the Law firm of Doll, Jansen and Ford.
- Teamsters Union Local 407 reserves the right to make changes to or discontinue this program at any time.

Scholarship Payment

- The scholarship may be applied to payment of tuition, room, board and other educational expenses such as books, fees, etc.
- The monies will be paid directly to the eligible educational institution by Teamsters Union Local 407 on behalf of the Teamsters Union Local 407 Scholarship Program at the beginning of the academic year.

Obligations of Scholarship Winners

Traditional scholarship winners are required to enroll full-time in a course of study at a four-year accredited college or university, two-year community college or technical school. All institutions must be Pell-eligible. Teamsters Union Local 407 will award three (3) non-renewable scholarships for academic year 2023-2024 (one at \$2,000, one at \$1,500, one at \$1,000). The scholarship payment will be sent at the start of the fall semester.
